Contest Rules, Terms and Conditions:

1. The 2008 Cinco de Mayo Fiesta Photo Contest is open to all ages.
2. The photographs must be taken at the 2008 Cinco de Mayo Fiesta on St. Paul's West Side. This event will be held on Friday, May 2 and Saturday, May 3, 2008.
3. Photography entries must be the work of the entrant.
4. **All photographs become the property of the Riverview Economic Development Association (REDA) and will not be returned.**
5. There will be two categories, and each participant is limited to one **entry per category (two photos)**
6. Photographs may be black and white or color.
7. Photographs must be submitted to the REDA office before, **Wednesday May 14, 2008 at 4 p.m.** Print size must be at least 4 inches by 6 inches.
8. Damaged photographs will not be accepted. Pictures cannot be stapled or folded. Neither the back nor the front of the photograph should be written on.
9. REDA is not responsible for late, lost, damaged, destroyed or misdirected entries or for miscommunications, misdirected transmissions, or other errors of any kind whether human, mechanical or electronic.
10. REDA reserves the right to use the photographs in printed materials or websites for exhibition, advertising, educational, publicity and/or promotional purposes.
11. Prizes will be awarded in each category to 1st place and 2nd place only. One award maximum per entrant.
12. The judging of the photographs will be conducted on or about May 17, 2008. Winners will be notified by first class mail within 14 business days of the judging. Winners' names will be posted on the District del Sol Web site and local press will be notified. The judge's decision will be final.

If, for any reason, the contest is not capable of being conducted as planned, including any causes beyond the control of the administrator of the contest, REDA reserves the right, at its sole discretion, to cancel, modify, suspend or terminate the contest without notice to the entrants.

Contest entrants by signing this form agree to abide by the terms of these official rules and by the decisions of the judging organization, which are final on all matters pertaining to contest. Entrants grant REDA the right to use and publish their name online, in print, or in any other media format, in connection with this photo contest.
