Please note participant must be present to receive award.**

## General Rules & Regulations:

- REGISTRATION:** All vehicles must check in before 4 p.m. on Friday May 6, 2011. Check in will start at 1:00pm and will take place in the Gross Givens parking lot on Plato Street. Security will be available for placement assistance.
- JUDGING CARD:** Each entrant will be given a registration/judging card at check in. The Registration/Judging card must be placed on the dashboard and visible to the judges. It is the entrant's responsibility to ensure that the registration card is visible and properly completed by starting time. Vehicles not displaying the judging/registration card will not be judged.
- OPERABILITY.** All entrants of the hydraulic showdown must be able to drive into the show area.
- COMMON COURTESY:** Be polite and considerate to all guests - remember that you are representing the Cinco de Mayo Fiesta Lowrider Car Show and the car club you are affiliated with. Profanity and other disrespectful conduct including displays which incorporate objectionable music, videos, artwork or other items is prohibited.
- EXCESSIVE NOISE:** Loud music should be kept to a minimum.
- DISTRIBUTION OF MATERIALS: Distribution of any materials during the Lowrider Car Show is prohibited.** This includes but is not limited to: leaflets, flyers, candy and/or propaganda.

7. **SAFETY CONCERNS:** Children under 12 years of age **MUST** be adequately supervised/accompanied by an adult during all periods of the car show. Also, for safety of participants **NO** pets, bikes, skateboards and rollerblades are allowed on the festival grounds.
8. **ALL EXHIBITION AND SAFETY RULES APPLY/DISQUALIFICATION:** All entrants must adhere to the "Exhibition and Safety Rules" of the Show, which are incorporated by reference herein. Failure to comply with any Exhibition and Safety Rule may be grounds for disqualification, at the sole and participate may be asked to leave the premises
