**REDA has partnered with Kaposia, Inc. to make the streets of District del Sol litter free!**

Starting December 1st, a work crew from Kaposia, Inc started in the District del Sol Commercial Corridor to pick up litter and empty public trash cans into the dumpsters of sponsor businesses. This schedule will continue every other week throughout the year. 19 District del Sol businesses have sponsored 21 public garbage cans as part of the campaign against litter.

Kaposia, Inc. is a West Side non-profit that provides employment opportunity for people with disabilities.
